The execution of the joint venture agreement was approved by the Board of Directors' Meeting No. 2/2023 held on 7 April 2023 to establish a joint venture company, which will be an additional subsidiary of the Company, to conduct a business of furniture distribution overseas with the details as follows:

Company's Name : ECF Design Company Limited

Registration Date : Expected to be registered within July 2023 and to commence

its commercial operation within July 2023.

Objectives : To conduct a business of furniture distribution overseas.

Registered Capital : Baht 7,000,000 (seven million), divided into 70,000 (seventy thousand)

shares, with a par value of Baht 100 (one hundred) per share.

Considering the value of the transaction size, the total highest transaction is 0.09% based on the total value of consideration basis calculated from the total value of consideration according to shareholding which is equal to Baht 3.57 million in accordance with the Company's latest review consolidated financial statements for the 1st quarter of the year 2023 ended 31 March 2023. The Company has no asset acquisition transactions that occurred during the 6-month period prior to the date of this Board of Directors' Meeting for the establishment of a subsidiary and the investment in the business of furniture distribution overseas.
